**CIRCULAR**

**All Ship Masters of Vessels visiting Port of Tuticorin**

The V.O.Chidambaranar Port Trust is a ISPS compliant Port. Security Level 2 is declared.

As per the ISPS code, Pilots are designated as Asst Port Facility officer and are authorized to sign the declaration of security with the master of the vessel on behalf of Port Facility Security Officer.

The vessel of international voyage should be in possession with Certificate as per ISPS Code. If the vessel is not in possession of the ISSC certificate, Asst PFSO will intimate PFSO.

Declaration of security (DOS) form should be agreed and filled between Master and Asst. PFSO on arrival.

All persons entering the Port premises are carefully screened before issuing the Gate Entry Pass. These passes to have photo I. D's which have to be displayed. Non -conformity leads to denial of access to the Port.

All passenger boats and barges which may have ship/ boat or ship/ barge interface are sanitized regularly by the Port Security Launch. All crew belonging to the above-mentioned crafts have been issued Photo Identity Cards after proper screening.

All Non-ISPS code compliant vessels including local fishing crafts will not have any interface with foreign going vessels. The Port of V.O.Chidambaranar states that all Security measures at Security Level 2 will be strictly adhered to without any contravention.
